## 3. PRODUCT DESCRIPTION

PRO NET II is a mild acid cleaner designed for grout and ceramic tile maintenance to remove most domestic stains and cement grout haze.

### Features

- ♦ Use on cementitious, pre-mixed and epoxy grout
- ♦ Use on countertops, floors, walls, showers, shower doors and toilets

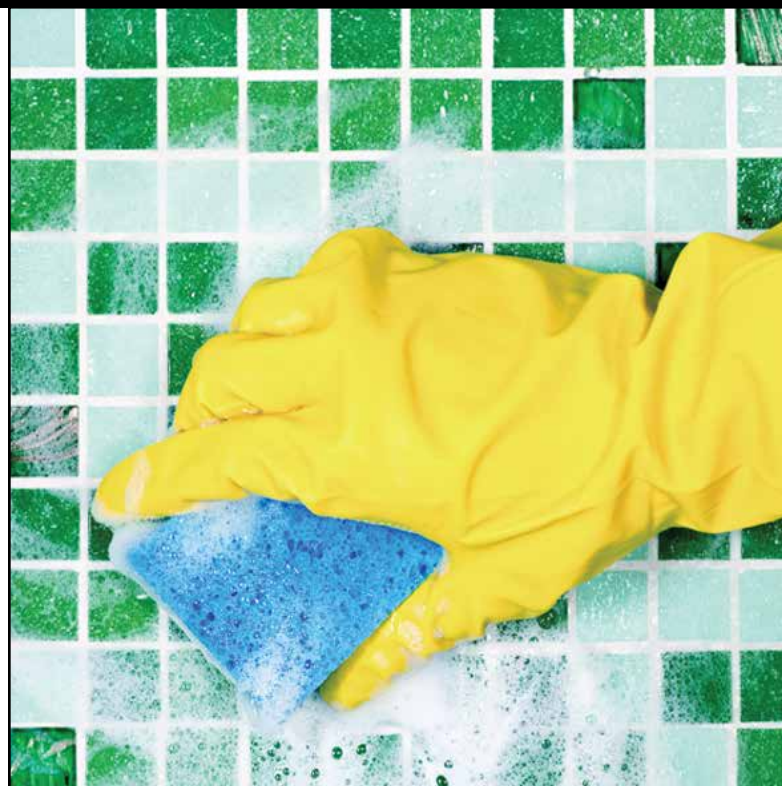

## 5. USAGE

### PREREQUISITE CONDITIONS

- ♦ Test first on a small and adequate surface, to assess results.

### Application and Mixing

**Note:** Grout must be fully cured at least 28 days old prior to use. Test on a small area to determine ease of application and desired results. Wear gloves and safety glasses when using this product, and protect neighboring areas against unexpected contact with product to avoid possible damage.

### Regular Cleaning Showers and Baths

1. Spray ready to use formula directly on the surface and scrub with a white scuff pad.
2. Rinse with clean water.

### Regular Cleaning Floors

1. Mix 100 mL (3.4 oz) of concentrated cleaner with 4 L (1.05 US gal) of water.
2. Clean the floor as usual with a mop, a sponge or a nylon scuff pad. Rinse with clean water.
3. For stubborn stains, allow the cleaning solution to work 1 to 2 minutes, scrub and wipe. Increase cleaning solution concentration if needed.
4. If the surface becomes sticky after drying, it is because of the presence of soap residues left on the surface. Rinse the surface with warm to hot water and wipe off.

### Deep Cleaning Grout and Tiles

1. Spray or pour undiluted directly on the joints and tiles and let work 1 to 2 minutes.
2. Scrub the joints with a white or black nylon scuff pad or a nylon brush.
3. Rinse thoroughly with clear water.

### To Remove Light Efflorescence, Cement Grout Haze, Light Rust Stains and Calcium Deposits

1. Pour undiluted directly on the surface and let work 1 to 2 minutes.
2. Scrub surface with a black or white nylon scuff pad or a hard bristle nylon brush.
3. Rinse with clean water and wipe off.

## Application Issues

### Efflorescence or Whitish Residue Still Visible on Grout After Cleanup

#### Main causes

- ♦ Too much water used in the grout mixture.
- ♦ Excessive water used to remove grout residue on tiles during cleanup.

#### Corrective measures

- ♦ If efflorescence is still visible after using PRO NET II, try cleaning the grout lines with PRO EFFLONET™ II (see respective data sheet for details). This product has the capacity to etch the surface of the grout lines and remove all minerals that migrated to the surface during the drying period.
- ♦ If a whitish residue is still visible on the grout after cleaning with EFFLONET II, then it is not efflorescence but lack of color pigment in the grout as a result of using too much water during cleanup of the grout residue. Recolor grout using PRO COLOR PREMIUM™ grout colorant to correct this issue (see respective data sheet for details).
